Question:

- 2. In 2020, how many patients were admitted to the ME-CFS service at the Astley Ainsley hospital in Edinburgh for ME?
- 3. In 2021, how many patients were admitted to the ME-CFS service at the Astley Ainsley hospital in Edinburgh for ME?
- 4. In 2022, how many patients were admitted to the ME-CFS service at the Astley Ainsley hospital in Edinburgh for ME?

Answer:

If admission means admission to an inpatient bed, then we do not admit patients with ME/CFS for inpatient rehabilitation. Inpatient rehabilitation is only for patients who are unable to exist in their own homes, due to the severity of their disability to extent that they cannot manage continence, making light snacks or dressing for instance. This is not usually the case for someone with ME/CFS.
