ENVIRONMENTAL INFORMATION - RAAC

I write in response to your request for information in relation to RAAC within NHS Lothian.

Question:

- 1. How many hospitals are affected by RAAC concrete in your health board?
- 2. How many wards and patients are affected by RAAC concrete?
- 3. How much money do you spend monthly to make sure that hospitals and hospitals wards to ensure they are safe to use?
- 4. How do you ensure patients safety when In a ward that contains RAAC concrete?

Answer:

- Detail on sites impacted by RAAC, and those that are not impacted following testing, are included on the NHS Lothian website (Reinforced Autoclaved Aerated Concrete Capital Developments (nhslothian.scot)*
- 2. The website above denotes the location RAAC has been discovered (building/area/ward etc).

No patients have been affected or moved.

- 3. We are not clear if this is specifically related to RAAC or in general. However, without a more specific question we would not be able to answer this, and it is unlikely that all costs related to this will be available in a centrally extractable format.
- 4. Patient safety, directly to relating to presence of RAAC, will be dependent on a number of factors. Where there is any immediate danger to patient safety the necessary precautions would be taken which may include a decant of the area.

Ultimately the intrusive surveys being done will determine the actions required.

If you remain dissatisfied with the Commissioner's response you then have the option to appeal to the Court of Session on a point of law.

If you require a review of our decision to be carried out, please write to the FOI Reviewer at the email address at the head of this letter. The review will be undertaken by a Reviewer who was not involved in the original decision-making process.
