I write in response to your request for information in relation to accidental deaths.

Question:

- The number of deaths that were considered avoidable\* from 1st January 2018 31st December 2023?
- Can this be broken down by year?
- Of those deaths, how many were due to the following causes: Alcohol-related and drug-related, Congenital malformations, Diseases of the respiratory system, Infectious diseases, Injuries, Pregnancy, childbirth and the perinatal period?

Answer:

I am advised that our Analytical Services does not hold data to answer this request in a centrally extractable format.

Under the Freedom of Information Act NHS Lothian is not required to create new records to enable it to respond to your enquiry. This information is not collated or held in aggregate form and it would be necessary to review all case files relating to patients over the period you have requested to assemble the information you seek. Even if NHS Lothian did this – and there would be significant cost implications in doing so – it would be unable to respond in full to your request. The information requested is therefore exempt under section 12.1 - Cost.

National Records of Scotland produce a publication on avoidable mortality, which includes some NHS Board level breakdowns, which might be of interest.
