I write in response to your request for information in relation to the Royal Infirmary of Edinburgh Intensive Care Unit in NHS Lothian.

Question:

1. Please disclose the full amount in cost in total to keep one person in a hospital bed for one day (24 hours) on 23/09/2022 at The Edinburgh Royal Infirmary intensive care unit.

Answer:

The average cost is £3,300 per day. This includes all direct staffing and non staff costs and a share of indirect costs (overheads) such as utilities.

Question:

- 2. Please disclose the number of hospital beds in total on 23/09/2022 at The Edinburgh Royal Infirmary intensive care unit specifically and how many of them were occupied and how many were not occupied for that full 24 hour period.
- 3. Please disclose the number of hospital beds in total on 23/09/2022 at the Royal Edinburgh Infirmary at its intensive care unit that were sought for patients within that 24 hour period.
- 4. Please disclose the same statistics asked at A, B and C for the dates of the 24th and 25th of September 2022 as well.

Answer:

The average cost of a critical care stay calculated for the year and is the same for these dates.

The table below details the information you have requested for the dates 23-25 September 2022 in the critical care wards 116 and 118 at the Royal Infirmary of Edinburgh.
