## FREEDOM OF INFORMATION – CAPITAL PROJECT FUNDING

I write in response to your request for information in relation to capital project funding in NHS Lothian.

Question:

1. The new RIE opened in 2002. Since then a number of other new capital projects have come along - including but not excluded to Midlothian Community Hospital, East Lothian Community Hospital, the redeveloped campus at Royal Edinburgh Hospital, The Royal Hospital for Children and Young People. How many of these were funded from the public purse - via direct Capital from the Scottish Government, and how many required to be funded via public finance initiatives or NPD? It is well known that both RIE and RYCYP were privately funded, but what of the others?

2. What has been the annual revenue cost implications for NHS Lothian of meeting the various contracts covering maintenance and other issues as part of any PFI/NPD project - broken down by project please? And the expected total cost of each project taking these contracted liabilities into account.
