I write in response to your request for information in relation to menopause clinics

Question:

1. Do you offer access to menopause clinics, through GP referral?

Answer:

Yes.

Question:

2. If so, can you please give us a breakdown of the number of referrals made each year since 2019-2020, up to and including 2023-24?

Answer:

We do not store this data as referrals come in a variety of ways, from informal, GP letters, email responds, clinical advice requests from other healthcare colleagues. We do not actively record the number of referrals from any of these methods.

Under the Freedom of Information Act NHS Lothian is not required to create new records to enable it to respond to your enquiry. This information is not collated or held in aggregate form and it would be necessary to review all case files relating to patients over the period you have requested to assemble the information you seek. Even if NHS Lothian did this – and there would be significant cost implications in doing so – it would be unable to respond in full to your request. The information requested is therefore exempt under section 12.1 – Cost.

3. What is the current average wait time between referral and first appointment?

Answer:

Current wait for new menopause appointment 21weeks.
