#### FREEDOM OF INFORMATION – WET-AMD INJECTIONS

I write in response to your request for information in relation to wet-AMD injections.

## Question:

1. What is the maximum number of wet-AMD injections you can facilitate in a week?

#### Answer:

20 lists per week across Princess Alexandra Eye Pavilion (PAEP) (16) and St John's Hospital (4), 14 injections per list

#### Answer:

a.	Previously yes.

The patients on TRAK based on further discussion with Loraine, unfortunately these patients do not go on a waiting list as such, they are booked asap into an appointment. The data is not recorded in such a way for me to pull back a waiting time.
