I write in response to your request for information in relation to psychedelic substances.

Question:

- 1. How many times 'microdosing' psychedelic substances was included as a reason for admissions to your hospitals in 2022, 2023 and 2024 to date.
- 2. How manytimes the consumption of psychedelic substances in any quantity was included as a reason for admissions to your hospitals in 2022, 2023 and 2024 to date.
 - Such substances include but are not limited to:
 - Magic Mushrooms (e.g. Psilocybin)
 - MDMA
 - o LSD
 - o DMT
 - Ayahuasca (e.g. Harmaline)
 - Salvia

MDMA and DMT are coded to F15.- Mental and behavioural disorders due to use of other stimulants, including caffeine

Ayahuasca and Salvia would be coded to F19.- Mental and behavioural disorders due to multiple drug use and use of other psychoactive substances

F' chapter codes relate to misuse and not overdoses
