Question:

- Number and proportion of bed days in your health board, by month since January 2018, occupied by patients who were at that time delayed in being discharged. Please also break this down by hospital.
- 2. Number and proportion of bed days occupied in your health board, by month since January 2018, by patients delayed in their discharge due to lack of social care availability.
- 3. Total bed day capacity in your health board, by month since January 2018.

Answer:

If you remain dissatisfied with the Commissioner's response you then have the option to appeal to the Court of Session on a point of law.

If you require a review of our decision to be carried out, please write to the FOI Reviewer at the email address at the head of this letter. The review will be undertaken by a Reviewer who was not involved in the original decision-making process.
