### FREEDOM OF INFORMATION – DELAYED DISCHARGE

I write in response to your request for information in relation to delayed discharge within NHS Lothian.

**Question:**

- Monthly and annually, from 2018 to present, for all patients discharged after a stay with at least some period of delayed discharge, what proportion of their stay was attributable to delayed discharge? Please provide the mean, median, 25<sup>th</sup> percentile, 75<sup>th</sup> percentile, 90<sup>th</sup> percentile, and 95<sup>th</sup> percentile proportions.

If our decision is unchanged following a review and you remain dissatisfied with this, you then have the right to make a formal complaint to the Scottish Information Commissioner within 6 months of receipt of our review response. You can do this by using the Scottish Information Commissioner's Office online appeals service at [www.itspublicknowledge.info/Appeal](http://www.itspublicknowledge.info/Appeal). If you remain dissatisfied with the Commissioner's response you then have the option to appeal to the Court of Session on a point of law.

If you require a review of our decision to be carried out, please write to the FOI Reviewer at the email address at the head of this letter. The review will be undertaken by a Reviewer who was not involved in the original decision-making process.
