FREEDOM OF INFORMATION REVIEW – DELAYED DISCHARGE

I write in response to your request for review of NHS Lothian's response to your Freedom of Information request about the longest delayed discharge. Having discussed your request and our response of, 1 May 2024, with our Caldicott Guardian and Information Governance Manager I can respond as follows:

Original Request and Response:

Question:

1. Annually, since 2015, the longest time a single patient remained in a hospital in your health board due to delayed discharge. Please provide both the total length of their stay, and the length attributable to delayed discharge.

Answer:

I must advise that due to the specific nature of your request it is not possible to provide an answer. The information is considered exempt under Section 38(1)(b) of the Freedom of Information (Scotland) Act 2002 – personal information. The requested information would allow for the identification of a singular individual and cannot be masked in a way that would allow us to respond.

Review Request:

I would like to request a review of this decision. Multiple other health boards have fully complied with this request, demonstrating that the overwhelming consensus of FOI officers is, rightly, that providing this information is appropriate under the FOI act. This does not compromise personal information. It is totally anonymised, much like the data either publicly published or obtained through FOI requests for so much other NHS patient activity.
