Requests come to the Staff Bank office from service leads who review staffing levels. If gaps are not filled by substantive or bank staff, the service lead requests agency support. This is arranged through the NHS Lothian Staff Bank office. All agency staff are added to our system by the staff bank office once governance checks have been carried out.

• Who is responsible for agency usage (on and off framework) in the Occupational Therapy department at all hospitals associated with the Trust within Occupational therapy?

### Answer

Agency requests are processed by Staff Bank office when received from service area. The request sent to framework agencies initially, then to off-framework if required. Framework rates in line with national agreement that services are aware have been agreed with procurement. Any rates for off-framework are agreed with service before accepting the booking.
