2. How does your Health Board assess if a prescriber is active or not?

Answer:

The Lead Pharmacist (non-medical prescribing) receives quarterly data from NES which pharmacists are requested to update annually. We then rely on individual pharmacists, and line managers to advise if a pharmacist is no longer an active prescriber. Currently we are developing processes to ensure that pharmacists inform the Lead Pharmacist Non-Medical Prescribing when their prescribing is temporarily suspended (e.g. parental leave, secondment). In addition, pharmacist prescribers will be required to complete an annual declaration and advise on their prescribing status. Leavers forms are also being updated to ensure that the pharmacist prescriber register is updated in a timeous manner.
