Your request should be made within 40 working days of receipt of this letter, and we will reply within 20 working days of receipt. If our decision is unchanged following a review and you remain



dissatisfied with this, you then have the right to make a formal complaint to the Scottish Information Commissioner within 6 months of receipt of our review response. You can do this by using the Scottish Information Commissioner's Office online appeals service at www.itspublicknowledge.info/Appeal. If you remain dissatisfied with the Commissioner's response you then have the option to appeal to the Court of Session on a point of law.

If you require a review of our decision to be carried out, please write to the FOI Reviewer at the email address at the head of this letter. The review will be undertaken by a Reviewer who was not involved in the original decision-making process.

- Table 1 & 2 notes: 1. The source of the hospital inpatient data in Table 1 and Table 2 is NHS Lothian TRAK. This is a live system if this analysis were to be re-run at a later date the figures may be subject to change.
 - 2. The Analytical Team does not hold readily available data on the number of patients diagnosed with a given medical condition. We have therefore provided the number of inpatient hospital admissions where a condition was mentioned in the hospital discharge notes. The condition might not be the main reason for admission. Please also be aware that patients with these conditions that have not been hospitalised in Lothian will not appear in our reported numbers.
 - 3. Please note that we have a data lag of 3 months from hospital discharge date due to coding and data processing times, so these numbers will only reflect inpatients discharged more than approximately 12 weeks ago. The figures for 2024 are therefore slightly incomplete.
 - 4. Counts are for hospital admissions rather than people.
 - 5. Each condition has been defined using the ICD10 codes listed in the table. Please see the World Health Organisation's website for information on what each code corresponds to.
