## FREEDOM OF INFORMATION – CERVICAL CANCER

I write in response to your request for information in relation to cervical cancer self-sampling.

Question:

• Has your health board piloted self-sampling as a means of identifying cervical cancer in women?

## Answer:

Self-sampling for cervical cancer has not been piloted in NHS Lothian. This is in line with other Scottish Health Boards while guidance is awaited from the UK National Screening Committee (UK NSC). All changes to national screening programmes are decided by the UK NSC and must meet the UK NSC criteria for population screening programmes. Results and recommendations are now available from several pilots and trials conducted in England to assess the feasibility and effectiveness of self-sampling for cervical screening.

The UK National Screening Committee (UK NSC) has consulted on the following recommendation and is expected to make a decision in April 2025.

Self-sampling for HPV testing should be offered to under-screened people eligible for the NHS Cervical Screening Programme in the 4 UK countries, where service commissioners think self-sampling would be a helpful addition to the programme.

If implemented, the HPV self-sampling option would be offered to under-screened people alongside traditional clinician-collected sampling. In preparation for a positive recommendation, the Scottish Cervical Screening Programme has established a group to plan for and implement self-sampling. Information from that group will be routed through already established governance groups that are attended by relevant senior leads for the cervical screening programme in NHS Lothian.
