How many do you fill in your pharmacy aseptic unit per year? Which drugs do you fill in your pharmacy aseptic unit?

Answer:

Our pharamcy do not fill the pumps for us. Anaesthetists fill the pumps in theatres.

We mostly purchase the empty Baxter SV2.5 folfusor devices for haematology/oncology which are filled with 5FU (a small number of their other sizes also filled). These are filled at both St John's Hospital and Edinburgh Cancer Centre (ECC) and between the sites/sizes we fill approximately 1000 per year.

There are also Smiths Medical CADD 250ml devices filled at ECC with cytarabine and they go hand in hand with a prefilled folfusor containing sodium chloride. Usage is around 80 per year of each.

The only other drug purchased in such a device is desferrioxamine prepared by the Royal Free Hospital in Baxter Adriamed Easyflow Infusors. Less than 5 patients per year under the care of the Haematologists and approximately 500 devices purchased.
