NHS Lothian took the decision on 26th June 2013 to cease providing NHS Lothian homeopathy services as from 1st April 2014. At the same time, GPs were asked to cease any out-of-area referrals to Glasgow Centre for Integrative Care (GCIC) (formerly known as Glasgow Homeopathy Hospital). There was an arrangement put in place whereby GPs could request referral to GCIC for homeopathy on an exceptional basis via the NHS Lothian Safe Haven office for out-of-area referrals. During the years 2022 – 2025 there have been no such requests.

The other therapies listed above are not ones which NHS Lothian funds.
