FREEDOM OF INFORMATION - MRI SCANNERS

I write in response to your request for information in relation to MRI scanners.

Question:

- 1. How many MRI scanners does the NHS in Scotland have?
- 2. How many are suitable for Patients with a high BMI and are obese and cannot fit in an MRI scanner?
- 3. How many MRI scanners does Lothian NHS have?
- 4. How many are suitable (in Lothian NHS) for obese patients with a high BMI?
- 5. How many patients, who are deemed obese, and cannot fit in an MRI scanner, have been sent to a private institution, such as SPIRE, to have an MRI scan?
- 6. How many obese patients, who cannot fit in the MRI scanner at the ERI, has the Department of General Surgery sent to either a private institution or to the zoo (any zoo) where the MRI scanners are apparently able to scan larger patients and animals?

Answer:

2.	Most scanners are larger bore nowadays, but again we cannot comment fot NHS in
	Scotland as a whole.

4.	All the scanners in Lothian are 70cm bore(large bore), there are very few who cannot
	fit.
5.	Spire do not have a larger bore scanner so none.
6.	This is a myth and Edinburgh zoo do not have an MRI scanner and the Vet school
	images animals only. If a patient can not fit in an MRI scanner in Lothian, there is no
	further pathway.
