Question:

- What is the current policy in your health board area for patients to request same-sex care, particularly in situations involving intimate examinations or procedures? Are patients able to request same-sex care from their GP or healthcare professional (same biological sex), particularly when they are undergoing intimate exams?
- When was this policy first enforced in your health board?
- Can you provide a copy of this policy.

Answer:

I am advised we do not have a policy specific to same-sex care. We do make every effort to accommodate these requests and in most cases are able to do that.

You can do this by using the Scottish Information Commissioner's Office online appeals service at www.itspublicknowledge.info/Appeal. If you remain dissatisfied with the Commissioner's response you then have the option to appeal to the Court of Session on a point of law.

If you require a review of our decision to be carried out, please write to the FOI Reviewer at the email address at the head of this letter. The review will be undertaken by a Reviewer who was not involved in the original decision-making process.
