I write in response to your request for information in relation to General Surgery Outpatient waiting times.

Question:

• I am looking for the waiting list for General Surgery Outpatient for Edinburgh Royal Infirmary, as my consultant says its 2 yrs and your website states 47 weeks. It is specifically surgery for a very large abdominal hernia and I am on the waiting list at the Edinburgh Royal Infirmary since 2024 for Mr Aldridge. But I was on Mr Manders waiting list for 2 yrs before going onto Mr Aldridge's list. So I would like waiting times for both consultants to be accepted onto their waiting lists to have an appointment with them and then also through to the actual waiting list for the actual surgery. Mr Aldridge says there are 2 just for him, one to be seen and one to have surgery. I would like waiting times since January 2022 to date to see what is holding up my surgery as I think 3 yrs is long enough.
