Notes on the data:

- 1. Due to how the triage outcome for referrals was recorded prior to 2023, we are unable to state specifically which referrals were referred back to primary care (GP) for 2022/23.
- 2. For question 5 we have provided the average appts for CAMHS patients who were referred and went on to receive treatment by year of discharge. The patients in this data set do not link directly with the patients in previous tables but the figures are indicative of the average number of attended appointments in these years.

I hope the information provided helps with your request.

If you are unhappy with our response to your request, you do have the right to request us to review it. Your request should be made within 40 working days of receipt of this letter, and we will reply within 20 working days of receipt. If our decision is unchanged following a review and you remain dissatisfied with this, you then have the right to make a formal complaint to the Scottish Information Commissioner within 6 months of receipt of our review response. You can do this by using the Scottish Information Commissioner's Office online appeals service at www.itspublicknowledge.info/Appeal. If you remain dissatisfied with the Commissioner's response you then have the option to appeal to the Court of Session on a point of law.

If you require a review of our decision to be carried out, please write to the FOI Reviewer at the email address at the head of this letter. The review will be undertaken by a Reviewer who was not involved in the original decision-making process.
