FREEDOM OF INFORMATION - MATERNITY RELATED DEATHS

I write in response to your request for information in relation to maternity related deaths in NHS Lothian.

Question:

1. Can I have copies of all information/reports held by the health board on maternity related deaths listed indicating whether the deceased was a mother or child. Can I have these figures presented yearly, from 2019/2024 inclusive. Can I also have the figures broken down by hospital.

Answer:

The tables below details incidents recorded under the categories of 'maternal death', 'neonatal death' and 'stillbirth'.

I have not released numbers of 5 or fewer in the tables, as this information could lead to the identification of the individuals involved. Since we do not have their consent to release their personal data, the information is exempt under section 38 of the Freedom of Information (Scotland) Act 2002 as to provide it would breach the principles of the Data Protection Act 2018.
