## FREEDOM OF INFORMATION – INSOMNIA PRESCRIBING

I write in response to your request for information in relation to insomnia prescribing.

### Question:

- In the last 12 months, how many unique patients have been treated for Insomnia (ICD-10 code G47.0) with the following products:
  - 1). Zopiclone
  - 2). Zolpidem
  - 3). Any other Melatonin product

### Answer:

We do not collect data in a way that records the indication for treatment against dispensing information. We can provide the total quantity of medicines dispensed if required, however there will be no link to the ICD code specified by the enquirer.

Under the Freedom of Information Act NHS Lothian is not required to create new records to enable it to respond to your enquiry. This information is not collated or held in aggregate form and it would be necessary to review all case files relating to patients over the period you have requested to assemble the information you seek. Even if NHS Lothian did this – and there would be significant cost implications in doing so – it would be unable to respond in full to your request. The information requested is therefore exempt under section 12.1 – Cost.

I am sorry I cannot help further with your request.

If you are unhappy with our response to your request, you do have the right to request us to review it. Your request should be made within 40 working days of receipt of this letter, and we will reply within 20 working days of receipt. If our decision is unchanged following a review and you remain dissatisfied with this, you then have the right to make a formal complaint to the Scottish Information Commissioner within 6 months of receipt of our review response.
