Answer:

We are only able to supply data for the amount that was spent via the NHS free condom budget.

2021-22 - £93.42 (HMP Addiwell)

Other service/departments may have purchased their own supplies, but we do not have data on this in a centrally extractable format. Under the Freedom of Information Act NHS Lothian is not required to create new records to enable it to respond to your enquiry. This information is not collated or held in aggregate form and it would be necessary to review all case files relating to patients and purchases over the period you have requested to assemble the information you seek. If you remain dissatisfied with the Commissioner's response you then have the option to appeal to the Court of Session on a point of law.
