FREEDOM OF INFORMATION - INFECTION RATES

I write in response to your request for information in relation to infection rates.

Question:

 Could I please request infection rates by hospital for orthopaedics and colorectal surgery and could I have the SSI and HAI rates for the hospitals

Answer:

I am advised we are unable to provide a meaningful response to the questions:

- "infection rates by hospital for orthopaedics and colorectal surgery" as this lacks specificity about which type of infections (for example wound, respiratory, urinary infections) for or over which time period data is being requested.
- "SSI and HAI rates for the hospitals" see note above.

NHS Lothian do not carry out formal surveillance of surgical site infection for <u>all</u> surgeries in all hospitals and are not required to do so.

Mandatory surveillance reporting of hip arthroplasty surgical site infection, and major colorectal surgery surgical site infection was paused at the start of the COVID pandemic in 2020 and has not yet restarted.

The Scottish Government are currently considering a proposal from Antimicrobial Resistance and Healthcare Associated Infection (ARHAI) national expert advisors on the future requirements for mandatory HAI and SSI surveillance programmes and instruction on this is anticipated by NHS Lothian in late Autumn/early Winter this year.

The ARHAI annual report (found here: <u>ARHAI Annual Report 2023-2024</u>) provides some more information on historic and current surveillance and performance. The annual report for 2024-2025 is not yet published.

If you remain dissatisfied with the Commissioner's response you then have the option to appeal to the Court of Session on a point of law.

If you require a review of our decision to be carried out, please write to the FOI Reviewer at the email address at the head of this letter. The review will be undertaken by a Reviewer who was not involved in the original decision-making process.
