I write in response to your request for information in relation to staff sickness absence.

Question:

- I would like to request the following information under the Freedom of Information (Scotland)
 Act (2002). For each month of 2020/21, 2021/22, 2022/23, 2023/24, 2024/25 and 2025/26
 (most recent):
 - 1. The number of staff working hours.
 - 2. The number of working hours lost to staff sickness absence.
 - 3. The number of working hours lost to staff sickness absence due to stress. (For clarification, if 'stress' is not available as a separate category please provide the name of the category it falls under and the total number of absent hours registered under this category).

Notes

Hours available calculated by multiplying the end of period WTE with the number of hours for full time. Based on Medical staff full time hours are 40 hours per week. All other staff (including Agenda for Change staff, Senior Managers, and non Agenda for Change staff) have been based on 37.5 hours per week 2020/2021 - 2023/2024. From 2024/2025 onwards they have been based on full time being 37 hours per week. The weekly hours were then multiplied by 52 (weeks in a year).

Unable to identify staff that has been off due to stress. Therefore data on the broader category 'Anxiety/stress/depression/other psychiatric illnesses' has been provided.

Your request should be made within 40 working days of receipt of this letter, and we will reply within 20 working days of receipt. If our decision is unchanged following a review and you remain dissatisfied with this, you then have the right to make a formal complaint to the Scottish Information Commissioner within 6 months of receipt of our review response. You can do this by using the Scottish Information Commissioner's Office online appeals service at www.itspublicknowledge.info/Appeal. If you remain dissatisfied with the Commissioner's response you then have the option to appeal to the Court of Session on a point of law.

If you require a review of our decision to be carried out, please write to the FOI Reviewer at the email address at the head of this letter. The review will be undertaken by a Reviewer who was not involved in the original decision-making process.
