#### 3. Selection process and criteria

Any documentation describing the criteria, scoring framework, or decision process used to determine which organisations were included in the PSP and at what funding level.

### 4. Service coverage and mitigation

Any recorded plan, briefing, or assessment explaining how the PSP intends to address impacts arising from the closure of the EIJB Grants Programme, particularly in relation to adult neurodivergent users such as those with ADHD or autism.
