# FREEDOM OF INFORMATION - MIDWIVERY AND OBSTETRICS SHIFTS

I write in response to your request for information in relation to midwifery and obstetrics agency shifts in NHS Lothian.

## Question:

1. How many midwifery shifts have gone unfilled after being put out for agency or bank cover, broken down by position and calendar years 2019, 2020, 2021, 2022, 2023, 2024 and 2025 (most recent data).

### Answer:

The information you have requested is detailed in the table below for bank and for agency midwifery shifts. Please note that the categories for recording position changed over time. And 'registered midwife' is the same as band 5, 6, 7 and 8c. The information for agency staffing has only been recorded in this format since 2021.
