FREEDOM OF INFORMATION - TRANSPLANT AND COVID-19

I write in response to your request for information in relation to transplant and Covid-19 guidelines.

Question:

 Did NHS Lothian implement the British Transplantation Society COVID 19 Guidelines (Guidance on the management of transplant recipients diagnosed with or suspected of having COVID 19) first published in the spring (24th April) of 2020? If so, what date was the guidance implemented?

Answer:

The document "Guidance on the management of transplant recipients diagnosed with or suspected of having COVID 19" was first released in March 2020 and was a joint British Transplant Society/Renal Association document. This was shared with the Transplant Unit for information. See enclosed. Updated guidance was available on 17/04/20 (again enclosed).

Policy, procedures and guidelines within the transplant unit and NHS Lothian was primarily derived from policy and guidance from Scottish Government Health Directorate, NHS Scotland, Antimicrobial Resistance and Healthcare Associated Infection Scotland (ARHAI), NICE and NHSBT. Guidance from professional representative organisations was available to staff but was not in itself implemented as policy; much of the professional guidance was consistent guidance from Government and NHS organisations.

In keeping with the primacy of Government and NHS guidance the BTS website now states "The current advice is changing daily and professionals are advised to refer to NHS and government resources for the most up to date advice." COVID-19 Information - British Transplantation Society.

I hope the information provided helps with your request.

If you are unhappy with our response to your request, you do have the right to request us to review it. Your request should be made within 40 working days of receipt of this letter, and we will reply











within 20 working days of receipt. If our decision is unchanged following a review and you remain dissatisfied with this, you then have the right to make a formal complaint to the Scottish Information Commissioner within 6 months of receipt of our review response. You can do this by using the Scottish Information Commissioner's Office online appeals service at www.itspublicknowledge.info/Appeal. If you remain dissatisfied with the Commissioner's response you then have the option to appeal to the Court of Session on a point of law.

If you require a review of our decision to be carried out, please write to the FOI Reviewer at the email address at the head of this letter. The review will be undertaken by a Reviewer who was not involved in the original decision-making process.
