FREEDOM OF INFORMATION – HIV TREATMENT

I write in response to your request for information in relation to HIV treatment.

Question:

- I am writing to request the following information under the Freedom of Information Act (FOIA). Please be aware that the distribution and analysis of this FOI request is sponsored by a pharmaceutical company.

Answer:

Please note that we can only go by the date drugs were issued to ward / clinic areas from our stock control system. These may be held in stock locally for ad hoc clinic issue and not necessarily fully reflective of date medications were issued to patient as this is not held on our system.

We have excluded patient counts due to variations on how these medicines are issued whereupon sometimes an "AN" number is used and sometimes an "UHPI", and we cannot link one to another. Also, in some instances patient identifiable data does not meet the threshold required.

If you are unhappy with our response to your request, you do have the right to request us to review it. Your request should be made within 40 working days of receipt of this letter, and we will reply within 20 working days of receipt. If our decision is unchanged following a review and you remain dissatisfied with this, you then have the right to make a formal complaint to the Scottish Information Commissioner within 6 months of receipt of our review response. You can do this by using the Scottish Information Commissioner's Office online appeals service at www.itspublicknowledge.info/Appeal. If you remain dissatisfied with the Commissioner's response you then have the option to appeal to the Court of Session on a point of law.

If you require a review of our decision to be carried out, please write to the FOI Reviewer at the email address at the head of this letter. The review will be undertaken by a Reviewer who was not involved in the original decision-making process.
