FREEDOM OF INFORMATION – RADIOLOGY REPORTING

I write in response to your request for information in relation to radiology reporting in NHS Lothian.

Question:

- For the period 1 January 2024 to 31 December 2024, and separately 1 January 2025 to 31 December 2025 (or, if more readily available, FY 2023/24 and FY 2024/25): The total number of Plain Radiography (X-ray / plain film) examinations performed by the Trust.

Answer:

Some MRI and CT scans were outsourced in 2023/24. Both the scan and the reporting were outsourced. The numbers are detailed in the table below. There was no outsourced reporting in 2024/25.

Your request should be made within 40 working days of receipt of this letter, and we will reply within 20 working days of receipt. If our decision is unchanged following a review and you remain dissatisfied with this, you then have the right to make a formal complaint to the Scottish Information Commissioner within 6 months of receipt of our review response. You can do this by using the Scottish Information Commissioner's Office online appeals service at <https://www.foi.scot/appeal>. If you remain dissatisfied with the Commissioner's response you then have the option to appeal to the Court of Session on a point of law.

If you require a review of our decision to be carried out, please write to the reviewer at the address at the top of this letter. The review will be undertaken by a Reviewer who was not involved in the original decision-making process.
